About Us

History

The Institute of Water Administration (IWA) has a proud history, commencing life as a group of Water and Sewerage Trust Secretaries in Gippsland getting together in 1967 to share ideas and experiences to improve their individual and collective administrative capability and performance.

During the next couple of decades the IWA became a statewide body and played a leading role in developing skills and networks which helped the industry transform during the 1980's and early 90's. By the mid 1990's the reform of the industry had reduced the number of Water Authorities by about 80%, and the IWA faced significant challenges with membership and attendances.

In 1997, the Institute responded to these challenges by undertaking a strategic planning process, which amongst other things, led to the birth of the Special Interest Groups, which have revitalised the IWA over the last decade or so.

Fast forward to 2013... the IWA and its Special Interest Groups (SIGs), in collaboration with VicWater and the Victorian Branch of the AWA, is still going strong.

Vision

To be recognised by the water industry in Victoria as the key forum for sharing information, networking and learning for executive management and business professionals.

Core Purpose

IWA exists to provide a forum for sharing information, networking and professional development in the Victorian water industry. IWA specifically targets our offerings to executive management and professionals managing business related functions within Victorian water corporations.

IWA's platform for delivering our services includes:

- Regular conferences addressing strategic and contemporary issues of interest to our target audience;
- Special Interest Groups which focus on a range of business functions within water corporations;
- Social networking opportunities to promote fellowship and collaboration; and
- Distinguished Service and Professional Development Awards.



President's Report

I have great pleasure in presenting this year's IWA Annual Report. This was my first year as President of the IWA and I must say it has been a rewarding journey.

In the last 12 months the IWA has continued to evolve to ensure it plays a meaningful and valuable role in the Victorian water industry. While some of the personnel have changed, the essence of what we're about – building knowledge, strong networks and collaboration – has not changed.

The highlight formethis year has been to witness the great work of the Special Interest Groups (SIGs). From my experience, few industries in the world can demonstrate the willingness to share to the extent the water sector does, and the SIGs exemplify this. As the saying goes, "people vote with their feet" – the high voluntary attendance at SIG meetings is testimony to the value attendees place on participation. Special thanks are due to the convenors of our SIGs, they are the backbone of the entire SIG network, providing great leadership and support to their peers. I encourage readers to look over the SIG highlights contained later in this report for a snapshot of the year's achievements.

Recognising the pivotal role the SIGs play in the IWA, and based on feedback from the SIGs at our annual strategic review, the IWA Executive has taken additional steps this year to support the SIGs. This included building stronger links between the Executive and the SIGs, and holding regular catch-ups with the SIG convenors prior to our conferences to coordinate on common issues and discuss current water industry context.

Our strategic review also identified a gap in the knowledge of the IWA amongst our membership. A presentation was developed (a copy is on our web site) to outline the IWA's history, its role and how the IWA fits within the

broader water sector context. The presentation was well received at the June 2013 SIG meetings and we're planning further communications to build awareness of the IWA.

This year we continued to build stronger links with VicWater, the key industry association for Victorian water utilities. We have a Memorandum of Understanding (MOU) with VicWater that recognises the mutual benefits of working together to support the Victorian water sector. This extends to promoting and coordinating events, consolidating administrative effort and sharing resources. Both the IWA and VicWater are committed to build on this strong foundation in terms of integrating our efforts and ensuring our ongoing effectiveness. I take this opportunity to thank Tony Wright, CEO of VicWater, for his support and engagement with the IWA over the year, which has been most productive and strategic.

Our three conferences for the year all enjoyed tremendous patronage, which I believe reflected the contemporary nature of the conference themes: "Innovation, from Ideas to Implementation" (sponsored by Western Water and AECOM), "Liveability – A Vision for the Future" (sponsored by Western Water, South Gippsland Water and Select Solutions), and "Enhancing Water Sector Productivity" (sponsored by GHD and Procurement Australia). Thanks go to all our conference sponsors and guest speakers, your support and participation is most appreciated.

A special highlight this past year was the awarding of the inaugural Laurie Gleeson Award. This Award, in honour of Laurie Gleeson's significant contribution to the IWA and the Victorian water industry, provides a unique development opportunity for people in our industry, and the field of candidates was



extremely impressive. The winner of the Award of \$5000 was Gwyneth Elsum, Energy Planner from Melbourne Water, who utilised the award to travel to the Netherlands to further investigate the idea of a Nutrient, Energy and Water factory. Due to the strength of the submissions and calibre of candidates, we also provided highly commended awards to Garrath Darkin, Senior Corporate Communications Advisor at Wannon Water and Lisa Ehrenfried, Water Source Strategy Project Manager at Yarra Valley Water.

A number of volunteers provide crucial support for the IWA. Not least amongst these is our Public Officer, Sarah Johnston from East Gippsland Water, who has worked tirelessly behind the scenes to support the effective functioning of the IWA. Sarah's diligence and knowledge of the workings of the IWA has been extremely helpful in my term as President. I'm also grateful for the support we've received from our Treasurer, David Thomas from Western Water, and our event support team including Kim Calvi from City West Water and Gail Reardon from the Australian Water Association (AWA). The Victorian branch of the AWA has worked closely with the IWA in coordinating and supporting our conferences.

As mentioned above, Vic Water has also provided tremendous support this past year and I'd like to thank April Jenkins for her contribution and in particular Belinda Goodwin, who has stepped in this year to coordinate our events and administration.

I also thank my fellow IWA Executive members; Peter Quinn, Joe Adamski, Les McLean, Ian Johnson, Paul O' Donohue, Neil Brennan, Brett Millington, John Wilkinson and Michael Malouf. I've enjoyed working with this dedicated team of water industry leaders.

The IWA is an organisation run by volunteers, and it is through the support of our water utility employers that we are able to fulfil our roles in

the IWA. I thank my employer, Yarra Valley Water, for its support during my tenure as President.

Finally, I have appreciated the opportunity to serve as President of the IWA in this, its 46th year, and I look forward to working with all members and the Executive Council in the future to continue to ensure the IWA makes a valuable contribution to the water industry. I offer my support and encouragement to our incoming President, Paul O' Donohue, for what promises to be an exciting forthcoming period for the IWA.

The Technical Services SIG had a year marked with high meeting attendance and several out-of-meeting discussions and working groups. Dean Boyd stepped aside from the convenor role at the end of 2012 after two years of successfully building up the group and creating the space where we would share openly and benefit from networking. The group is very grateful for Dean's contribution and vision in shaping and sharpening our focus.

An example of a major contributor to the workings of our SIG is Alan Tyson from Goulburn Valley Water, organising and driving the CFA issues working group and the hard waste management discussions.

The CFA working group is going to be coordinated by North East Water in 2013/14 with Goulburn Valley Water maintaining the lead on the hard waste management issues.

- The Technical Services Special Interest Group exists to provide a forum for sharing information, networking and professional development in the Victorian water industry.
- Attendance is very good, with usually around 30 members out of 55 active and almost 100 total members
- Attendees are from the metro and regional water corporations and many of our technical consulting businesses. No regulators attend unless to present on a specific topic.
- This year has seen significant changes in our regulators, both from a structure point of view and in their relationship

with us. The process for developing, submitting and finalising our Water Plan 3 corporate documents has taken a lot of resources and energy, with the NCC changing rules presenting ongoing challenges.

- The introduction of the Office of Living Victoria (OLV) and the draft strategy are highlighting a significant shift in thinking and operations within the sector. Individual water corporations are working to understand the details of those changes as is the industry as a whole.

Meetings

November 2012

- Hosted by Melbourne Water, the group undertook a tour of the Hoppers Crossing Pumping Station and Brooklyn Control Room before heading back to 990 Latrobe St for the remainder of the meeting.
- The group was provided with a confronting presentation by Martin Bowles in regards to the ETP Incident in December 2011 and the short and long term impacts this incident has had on staff as well as the way that Melbourne Water now approaches H&S issues and how EAs can assist managers and staff during such unfortunate events.
- The meeting also involved a panel discussion titled "How to think like an Executive" presented by several of Melbourne Water Executive Team which provided key insights into how Executives think and their expectations of an EAs role to best assist their daily needs.

 Key people driving the Energy Factories and Resource Factories Programs to discuss their approach and what the program was achieving.

- Attended the 2013 BlueTechTM conference with participants from across the northern hemisphere to gauge some of the leading edge technologies in the water industry.
- She visited several sites to observe innovative technologies working in practice. Specifically the NeredaTM technology in Epe; Co-digestion and heat distribution in Alperdoon; and methane extraction from ground water in a water treatment process aiming to be carbon neutral and now has a better understanding how a centralised body for applied research in the industry might work.

Upon returning she has had good discussions with colleagues across the industry about the technologies she saw and how they could be applied back in Australia. She is also inspired by the program water authorities in The Netherlands are running to actively create cross-sector dialogue and it is something she is pursuing here.

Note 1: Statement of Significant Accounting Policies

The financial report is a general purpose financial report that has been prepared in accordance with Accounting Standards and other authoritative pronouncements of the Australian Accounting Standards Board and the requirements of the Associations Incorporation Reform Act 2012.

The financial report covers Institute of Water Administration Inc. as an individual entity. Institute of Water Administration Inc. is an association incorporated in Victoria under the Associations Incorporation Reform Act 2012.

The following is a summary of the material accounting policies adopted by the economic entity in the preparation of the financial report. The accounting policies have been consistently applied, unless otherwise stated.

(A) Basis of Preparation

First-time Adoption of Australian Equivalents to International Financial Reporting Standards

Institute of Water Administration Inc. has prepared financial statements in accordance with the Australian equivalents to International Financial Reporting Standards (IFRS) from the 1 July 2005.

In accordance with the requirements of AASB 1: First-time Adoption of Australian Equivalents to International Financial Reporting Standards, adjustments to the company's accounts resulting from the introduction of IFRS have been applied retrospectively to 2005 comparative figures excluding cases where optional exemptions available under AASB 1 have been applied. These accounts are the first financial statements of Institute of Water Administration Inc. to be prepared in accordance with Australian equivalents to IFRS.

The accounting policies set out below have been consistently applied to all years presented. The entities have however elected to adopt exemptions available under AASB 1 relating to AASB 132: Financial Instruments: Disclosure and Presentation, and AASB 139: Financial Instruments: Recognition and Measurement. Refer the Notes for further details.

Reconciliations of the transition from previous Australian GAAP to IFRS have been included in Note 2 to this report.

Reporting Basis and Conventions

The financial report has been prepared on an accruals basis and is based on historical costs modified by the revaluation of selected non-current assets, and financial assets and financial liabilities for which the fair value basis of accounting has been applied.

Cash and Cash Equivalents

Cash and Cash Equivalents includes cash on hand, deposits held at call with banks or financial institutions, other short term highly liquid investments with original maturities of three months or less, and bank overdrafts. Bank overdrafts are shown within short term borrowings in current liabilities on the balance sheet.

Revenue

Revenue from the rendering of a service is recognised upon the delivery of the service to the customers and Members

Interest revenue is recognised on a proportional basis taking in to account the interest rates applicable to the financial assets.

All revenue is stated net of the amount of goods and services tax (GST).

Goods and Service Tax (GST)

Revenues, expenses and assets are recognised net of the amount of GST, except where the amount of GST incurred is not recoverable from the Australian Taxation Office. In these circumstances, the GST is recognised as part of the cost of acquisition of the asset or as part of an item of the expense. Receivables and payables in the balance sheet are shown inclusive of GST.

Cash flows are presented in the cash flow statement on a gross basis, except for the GST component of investing and financing activities, which are disclosed as operating cash flows.

Prepayments

Prepayments represents deposits for future conference facilities and expenditure for costs where a benefit is to be gained in a future period.

Comparative Figures

Where required by Accounting Standards comparative figures have been adjusted to conform with changes in presentation for the current financial year.
