
About Us

History

The Institute of Water Administration Inc. (IWA) has a proud history, commencing life as a group of Water and Sewerage Trust Secretaries in Gippsland getting together in 1967 to share ideas and experiences to improve their individual and collective administrative capability and performance.

The IWA's primary objective is to advance the standards of management within the water sector and making an active contribution to the future directions of the industry.

To ensure that the IWA continues to meet the needs of our members and the wider industry, in late 2016 (our 50th anniversary year), the IWA Board developed a strategic intent of 'helping the water industry to become more extraordinary' which now assists in planning future conferences and events. Adoption of this intent also assisted the Board to establish the following 'Why' statement based on the Simon Sinek model.



The IWA achieves this through providing a forum for sharing information, networking and professional development in the Victorian water industry.

The services include:

- Regular conferences addressing strategic and contemporary issues of interest to our target audience;
- Ten Special Interest Groups convened by volunteers which focus on a range of business functions including Finance, Technical Services, Customer Service, Information Systems, Governance, Human Resources, Education, Executive Assistants, PR/Communications and Electricity and Greenhouse;
- Distinguished Service and Professional Development Awards.

The IWA's services are achieved through a Board consisting of up to twelve elected representatives in addition to a nominated Treasurer and Secretary from amongst the Victorian water industry. The Board members volunteer their time and expertise in order to deliver the IWA's services.

The IWA is a not for profit association and has strong links to both the Victorian Water Industry Association and the Victorian branch of the Australian Water Association.

IWA Conference - November 2019

The IWA November 2019 Conference was held on 14 and 15 November 2019 at Crown, Melbourne. The timely theme for the conference was "Solutions for a changing climate" which was chosen as a follow up to the July 19 conference theme "Our water in a drying climate". The November conference featured presenters that focused positively on concepts to deal with climate change.

The conference was successful and featured a keynote presentation by Matt Kuperholz. PwC's Chief Data Scientist who gave the highest rated presentation on "How exponential technologies can address the water sectors challenges". The program then moved onto local solutions for climate change, focusing on customer behaviour research from metro and regional perspectives. There were also two presentations from previous Laurie Gleeson Award winners, Rosalind Martin and Dean Phillips who shared their learnings from their overseas travels.



The IWA Conference Dinner was held on Thursday 14 November at the River Rooms, Crown, Melbourne. President Dona Tantirimudalige compered the evening's proceedings which included the annual awards presentations, some farewells, as well as guest speaker Michael Rowland, ABC News Breakfast co-presenter, who had just returned from covering the NSW bushfires.

IWA Conference - March 2020

IWA SIG Meetings - July 2020

The IWA's third conference for the year was impacted by COVID-19 restrictions, therefore the dinner was unable to be held and the SIG meetings were held virtually. Despite the change of plans, SIG attendance was up 25% on July 2019 despite only 7 groups meeting, with Customer Service recording 67 attendees, the highest ever attended SIG meeting. One of the benefits to virtual meetings was there no capacity limit required for attendees unlike the physical meetings, so convenors could have many more attendees than usual. Attendees got a lot of value out of the virtual SIG meetings, with a lot appreciating having zero travel time, however the lack of networking was raised as one of the key benefits of attending face-to-face meetings that was difficult to replicate virtually. Laurie Gleeson Professional Development Award

Laurie Gleeson was Managing Director of Goulburn Valley Water for 28 years from 1980 to 2008. A keen advocate for reform, efficiency and high standards of customer service, Laurie played an active role in enhancing the performance of the water sector. He was a strong supporter of the IWA and the role it plays in contributing to professional development and collaboration in the Victorian Water Industry.

In honour of Laurie's significant contribution to both the Institute and the Industry, the Laurie Gleeson Professional Development Award was created at the IWA's 45th anniversary dinner in June 2012. - What is the expected total cost?

The 2020 winner Apanie Woods (Melbourne Water) was announced at the November 2019 conference dinner.

Apanie's submission outlined the challenges of balancing investment in emergency preparedness with the continued delivery of core services. Apanie proposes to learn from other agencies, and bring back innovative approaches and new ideas to share across the water sector in Victoria.

Report on the Audit of the Financial Report

Opinion

We have audited the financial report of Institute of Water Administration Inc. The committee of the association is responsible for the other information. The other information comprises the information included in the association's annual report for the year ended 30 June 2020, but does not include the financial report and our auditor's report thereon. Our opinion on the financial report does not cover the other information and accordingly we do not express any form of assurance conclusion thereon. In connection with our audit of the financial report, our responsibility is to read the other information and, in doing so, consider whether the other information is materially inconsistent with the financial report or our knowledge obtained in the audit or otherwise appears to be materially misstated. If, based on the work we have performed, we conclude that there is a material misstatement of this other information, we are required to report that fact. We have nothing to report in this regard.

Independent Auditor's Report to the Members

Responsibilities of the Committee for the Financial Report
