The Institute of Water Administration (IWA) has a proud history, commencing life as a group of Water and Sewerage Trust Secretaries in Gippsland getting together in 1967 to share ideas and experiences to improve their individual and collective administrative capability and performance.

The IWA's primary objective is to advance the standards of management within the water sector and making an active contribution to the future directions of the industry. The IWA achieves this through providing a forum for sharing information, networking and professional development in the Victorian water industry.

### **Special Interest Group (SIG) Reports**

## CUSTOMER SERVICE SPECIAL INTEREST GROUP – 2011/12 OVERVIEW

Our SIG covers a range of topics associated with the work undertaken by work units within water corporations dealing with our customers. All members of the group are associated with, or manage work groups who have day to day contact with all our customer groups.

We have seen regular attendance numbers for the past year in the low to mid 20's which is a slight improvement over recent years, with all metropolitan and regional water businesses represented at our meetings. The increase in attendance numbers over the past 12 months can be largely attributed to including water corporations from Tasmania in our group and the regional rural water businesses.

The major challenges facing all water corporations, regardless of their size, demographic or geographic location revolves around ensuring the best possible service to our customers in an ever evolving climate of change. This was done with an eye to the future in an attempt to be ahead of change or at worst not being left behind as demands and pressures increase on all customer service staff.

The EA SIG is established to facilitate Executive/Personal Assistants to Chairs, CEOs/MDs within the Victorian Water Industry by providing a forum to share industry best practice, knowledge transfer and professional development opportunities.

### Finance Special Interest Group – 2011/12 Overview

The Finance SIG meetings are designed to bring together representatives from water corporations and provide information on issues/topics that are common throughout the industry. All water corporations were represented at one or two of the SIG meetings with an average 40 people attending.

Three major accounting issues dominated the SIG in the 2011/12 year. They were:

- ♦ Water Plan 3
- Asset Revaluation
- ♦ Defined Benefits Funding Call

The work undertaken by all water corporations in meeting the regulatory requirements of the Water Plan 3 led to a major information sharing session at the February meeting. Representatives shared the challenges faced by their corporation as well as the different pricing options they were considering.

The wash up from the infrastructure revaluation was presented at the November meeting and the impact from the revaluation is material across all corporations. Consensus amongst the group was the next revaluation process will need to be better planned and delivered to avoid the mistakes made in 2010/11.

The magnitude of the Defined Benefits Funding Call was not known at the February meeting, but Vision Super indicated a major call was imminent. The impact on corporations was material and discussions amongst the group regarding the payment options and whether the cost should be included in the Water Plan 3 was beneficial.

## TECHNICAL SERVICES SPECIAL INTEREST GROUP – 2011/12 OVERVIEW

I am proud to report on the activities of the Technical Services Special Interest Group (TSSIG) for the 2011/12 year. During this period of heightened planning activity, particularly as water corporations were preparing Water Plans for the next regulatory period, the opportunities facilitated by the SIG meetings to reflect on the industry's differing approaches to the technical aspects was particularly helpful.

The purpose of the TSSIG is to explore matters relating to technical functions of interest to water corporations, including the broad areas of; engineering, asset management, service delivery, operation and maintenance, risk management, and related functions. Through the three meetings held, and numerous exchanges between members outside of meetings, the TSSIG has realised its aims as a forum for interaction between members and guests.

The TSSIG meetings are going from strength to strength, with attendances consistently exceeding expectations. During the year the number of attendees has been consistently high, varying between 23 and 25 at each of the three meetings held.

Attendees at TSSIG meetings included representatives from across the regional urban water corporations and from most of the Melbourne metropolitan businesses. Other attendees include representatives from several engineering consulting firms, as well as guest speakers from a range of agencies, regulators and other industry stakeholders and partners.

Having continued to build interest in and support for the group over the last two years, the major challenge is to maintain relevance to members and to clearly articulate purpose and benefits. Maintaining relevance to members is achieved by having interesting and challenging agendas and speakers - this is an ongoing challenge, and one that the group can directly control. The TSSIG agendas try to cover the whole range of subjects of interest to technical leaders in the industry - these include professionals working in areas as diverse as strategic planning, asset management, operations, maintenance, capital works design and delivery, process management, and related personnel and resource management. Having motivated group members supporting the convenor, through the agenda is obviously the key.

Major stakeholders/organisations with close linkages to the TSSIG include various consulting firms, a range of VicWater and DSE working groups (covering areas as diverse as, for example; Dams Working Group, Catchments Task Group, New Customer Contributions, Contiguous Boundaries, Asset Revaluation, Stock in Waterways, and others), our various regulators, including DSE, ESC, EPA, DoH, and other acronyms. TSSIG has also engaged with other stakeholders, including; Smart Water Fund, Intelligent Water Networks, VicRoads and others.

developer works and customer connections, and the definition of Non-Revenue water.

be able to identify relevant groundwater management agencies that undertake similar regulatory roles as Goulburn Murray Water, and learn about their management and impact on the community.

With increased demand, groundwater management is becoming more regulated and prominent in the community, improved consultation and consideration of the international groundwater management practices can contribute to management outcomes to address significant State and Federal water reform policy.

While Bob's particular patch may be the Murray Darling Basin, the learning's will be applicable to the whole state with a full report to be provided by Bob identifying how resource managers address; sustainable yields, consider groundwater surface interactions, consider groundwater dependent ecosystems and adapt to different groundwater management practices.

#### **Note 1: Statement of Significant Accounting Policies**

The financial report is a general purpose financial report that has been prepared in accordance with Accounting Standards and other authoritative pronouncements of the Australian Accounting Standards Board and the requirements of the Associations Incorporation Act 1981.

The financial report covers Institute of Water Administration Inc. as an individual entity. Institute of Water Administration Inc. is an association incorporated in Victoria under the Associations Incorporation Act 1981.

The financial report of Institute of Water Administration Inc. and the controlled entity and Institute of Water Administration Inc. as an individual parent entity comply with all Australian equivalents to International Financial Reporting Standards (IFRS) in their entirety

The following is a summary of the material accounting policies adopted by the economic entity in the preparation of the financial report. The accounting policies have been consistently applied, unless otherwise stated

#### (A) Basis of Preparation

First-time Adoption of Australian Equivalents to International Financial Reporting Standards

Institute of Water Administration Inc. has prepared financial statements in accordance with the Australian equivalents to International Financial Reporting Standards (IFRS) from the 1 July 2005.

In accordance with the requirements of AASB 1: First-time Adoption of Australian Equivalents to International Financial Reporting Standards, adjustments to the company's accounts resulting from the introduction of IFRS have been applied retrospectively to 2005 comparative figures excluding cases where optional exemptions available under AASB 1 have been applied. These accounts are the first financial statements of Institute of Water Administration Inc. to be prepared in accordance with Australian equivalents to IFRS.

The accounting policies set out below have been consistently applied to all years presented. The entities have however elected to adopt exemptions available under AASB 1 relating to AASB 132: Financial Instruments: Disclosure and Presentation, and AASB 139: Financial Instruments: Recognition and Measurement. Refer the Notes for further details.

Reconciliations of the transition from previous Australian GAAP to IFRS have been included in Note 2 to this report.

Reporting Basis and Conventions

The financial report has been prepared on an accruals basis and is based on historical costs modified by the revaluation of selected non-current assets, and financial assets and financial liabilities for which the fair value basis of accounting has been applied.

#### (B) Accounting Policies

#### **Cash and Cash Equivalents**

Cash and Cash Equivalents includes cash on hand, deposits held at call with banks or financial institutions, other short term highly liquid investments with original maturities of three months or less, and bank overdrafts. Bank overdrafts are shown within short term borrowings in current liabilities on the balance sheet.

#### Goods and Service Tax (GST)

Revenues, expenses and assets are recognised net of the amount of GST, except where the amount of GST incurred is not recoverable from the Australian Taxation Office. In these circumstances, the GST is recognised as part of the cost of acquisition of the asset or as part of an item of the expense. Receivables and payables in the balance sheet are shown inclusive of GST.

Cash flows are presented in the cash flow statement on a gross basis, except for the GST component of investing and financing activities, which are disclosed as operating cash flows.

#### **Prepayments**

Prepayments represents deposits for future conference facilities.

#### **Comparative Figures**

Where required by Accounting Standards comparative figures have been adjusted to conform with changes in presentation for the current financial year.
