2022/23 IWA Conference Overview



IWA Conference & SIG Meetings – November 2022

The IWA Conference was the first in-person event to be held by IWA since March 2020 and included the following components:

- Wednesday 16 November IWA Board / SIG Convenor Strategic Session & Dinner
- Thursday 17 November SIG Meetings, AGM and Conference Dinner
- Friday 18 November Half-day Conference

The Conference was held at Novotel Geelong with SIG Meetings also taking place at Barwon Water, who kindly hosted the overflow meetings. The conference theme, **'Creating the Future'**, focussed on what we can do now to plan for a successful future. Circular economy was a large area of focus, as well as workforce & people and how we respond to emergencies as a result of our changing climate.

The conference was strongly attended with 92 conference registrations, 110 dinner registrations and 220 SIG meeting registrations. The feedback survey results concluded that the event was very successful with all components of the event rating highly. IWA are very grateful to <u>TRILITY</u> and <u>Davidson</u>, our longtime conference sponsors.



IWA Plenary Session & SIG Meetings – March 2023

The IWA's second event for the 2022/23 financial year was the plenary session and SIG meetings that were held on 16 March 2023 and were run virtually.

The plenary presentation 'Scottish Water – planning for a sustainable future in an uncertain world' by Simon Parsons was very well attended with 132 registrants (up from 121 in March 2022), 93 live attendees (up from 85 in March 2022). The ratings of the plenary session were 48% rating 'Excellent' and 52% rating 'Very Good'. The session was recorded and available to rewatch to all those who registered.

The SIG meetings were also well attended with 332 SIG registrations (up from 295 in March 2022). Overall SIG meetings rated well with majority rating the meeting they attended as 'excellent'. Good feedback was received in the post event feedback survey and was consistent with previous events.





IWA Plenary Session & SIG Meetings – July 2023

The IWA's third event was the Plenary Session and SIG meetings which were held on 13 July 2023 and were run virtually. The plenary presentation '*Planning for El Niño and La Niña – ideas for an integrated approach for water corporations*' presented by Tony Wong was very well attended with 186 registrants (up from 114 in July 2022), 167 live attendees (up from 85 in July 2022). The session was recorded and available to rewatch to all those who registered.

The SIG meetings were also well attended with 376 SIG registrations (up from 232 in July 2022. Overall SIG meetings rated well with majority rating the meeting they attended as 'excellent'.

Good feedback was received in the post event feedback survey and was consistent with previous events.

Educators

Overview

The purpose of the Educators Special Interest Group is to allow educators from Victorian water businesses and other agencies to share ideas, hear from expert guest speakers, collaborate on shared resources, visit other educational sites and discuss issues related to water education across Victoria.

The group has active representatives from the majority of water businesses across Victoria. We also have representatives from DEECA, Schools Water Efficiency Program (SWEP), Sustainability Victoria and Catchment Management Authorities.

Collectively, the group has a rich diversity of skills and experience including science and engineering, teaching, stakeholder engagement, media relations, communications and marketing. The meetings provide networking opportunities and professional development for all members.

The challenge faced by water educators is that often there is one education staff member in a water business, who may perform other roles/tasks within their business. Allocating time and resources to education can at times be a secondary priority.

Major stakeholders/organisations with close linkages include: DEECA (SWEP program), Sustainability Victoria (ResourceSmart Schools program), Smiles 4 Miles, Department of Education and Training Victoria, early learning centres, primary and secondary schools, tertiary institutions and organisations that work with the Cultural and Linguistically Diverse (CALD community).

Environment

Overview

The Environment Special Interest Group exists to provide a forum for information sharing, networking, and professional development in the Victorian water industry.

There are currently 49 members registered for the Environment SIG from across 18 water authorities. The ability to hold virtual meetings has made the SIG meetings accessible to many that otherwise may not have attended due to distance. Attendance at all virtual meetings has continued to be high.

The group are positive about the contribution and information sharing these ongoing meetings are having on the water industry. Networking, sharing, and improving state of knowledge are strong benefits.

Meetings

17 November 2022

- The in-person meeting in Geelong provided an excellent opportunity for networking, allowing members of the Environment SIG to exchange ideas and information and get to know each other a little better.
- Key themes discussed included the 'Determination of the Authority under section 48 N S 306, provisions for exemption from development licence requirement when planning for a modification to a sewage treatment plant'. We joined the Technical Services SIG for presentations on applying the General Environment Duty to business operations, how the organisation Before You Dig works. The experience of water corporations following extreme weather events and the progress of the Victorian Murray River Floodplain Project.

16 March 2023

- A key discussion item centred around end of tenure for GVW as convenor of the Environment SIG meetings.
- Updates provided by water authorities in attendance generating some shared learnings regarding interpretation of new licence condition for HEMP implementation and decommissioning plans and how they relate to full plant decommissioning versus partial decommissioning of some assets.
- GVW shared a presentation on Dunyak Moira restoration of an abandoned reservoir for recreation and cultural use, an excellent demonstration of meaningful collaboration with Traditional Owners. Providing a valuable recreational resource for the whole community to enjoy.

17 November 2022

Leadership Changes - Marnie Rowden from Goulburn Murray Water took over as Convener; and Ian Mewburn of South Gippsland Water stepped in as Deputy.

Talent and Skill Deficit Addressal: WSAA emphasized on the prevailing challenges in leadership, digital proficiency, and critical analysis within the water sector.

Peter communicated the ambitions and stages of the EVP project, stressing on enhancing the industry's visibility and nurturing collaboration.

Hybrid Work Evolution: Kelly Crosthwaite from DELWP provided insights on transitioning to a hybrid work setup, emphasizing the significance of face-to-face interactions, clear guidelines, and consistent communication.

16 March 2023

Numerous companies began testing hybrid work structures, with some considering a 4-day workweek.

Learning and Development (L&D): Focus areas include leadership training, digital courses, and identifying skills gaps.

Major challenges identified were dam safety, the rise of automation, and senior staff exits due to wage-driven recruitment issues.

13 July 2023

Prioritising Mental Health: Increased emphasis on programs addressing workload, stress, and a holistic understanding of mental well-being.

Guest Speaker, Tanya Heany Voogt emphasized the recognition of burnout as an organizational syndrome and the importance of workplace mental health. Her platform offers free tools for organizations aiming for maturity in addressing psychological safety. New regulations will soon tackle five core psychosocial risks. The emphasis is on addressing outcomes over terminologies.

Engagement Challenges and Solutions: Glenda Smith, Goulburn Murray Water, discussed the noticeable engagement gap between corporate staff and field workers. Efforts by Goulburn Murray Water to enhance gender equity faced hurdles, but a merger of the OHS committee led to better engagement alignment. Open dialogues on job flexibility across roles have shown a positive influence on engagement levels.

The HR SIG has been diligent in addressing the evolving challenges of the sector, emphasising the importance of employee well-being, engagement, and continued learning throughout the year.

Information Technology

Brief overview:

The Information Technology SIG exists to provide a forum for sharing, collaboration, networking, problem solving and professional development in the Victorian water industry.

Major challenge(s):

- 1. There is an ongoing desire for collaboration to occur outside of meetings but this isn't occurring. I suspect this is due to a lack of resources to organise anything significant. Any available resources would be welcome.
- 2. There is difficulty in keeping the member list current. Often the first I know of someone leaving an organisation is when I get an email bounce back from the meeting invitation. I then have no idea about who has replaced them, or who else in that organisation would be appropriate to become a member and attend meetings.
- 3. The metros are consistently under-represented, which is disappointing because when they attend, they often discuss well developed systems and processes which are of interest to the other attendees. The metros also often have mature artifacts which they are open to sharing. I would like to see a representative from a metro take over the convenor position after my tenure finishes. I would think that this would help this situation as I would assume that the metro employees are possibly better connected to each other.
- 4. Personally, I find the face to face meetings more effective for making contacts because there is always useful discussions held over morning and afternoon tea and lunch. When online, this doesn't happen. That said, the face to face meetings have the lowest attendances.
- 5. The Round-The-State discussions are always valuable.
